Revised Charges in conjunction with Increase in Japanese Consumption Tax

Narita International Airport Corporation (NAA) announces that airport user charges will be revised in line with the consumption tax rate increase effective on 1 October 2019.

The increased consumption tax rate, from 8% to 10%, will be reflected on all charges collected at Narita Airport. Tax-inclusive charges will be revised as follows:

- ① Passenger Service Facility Charge (PSFC) and Passenger Security Service Charge (PSSC)
 Effective Date: The new charges will apply to passengers using the airport on or after 1 October 2019 with tickets purchased on or after this date. Present charges will apply to tickets purchased before this date.

*As before, PSFC and PSSC will be collected in conjunction with the airfare when passengers purchase their air tickets.

Effective Date: The new charges will apply to vehicles entering airport car parks after 12:00 a.m. on 1 October 2019.

Vehicles that have entered the car parks before that time, the present charges will be applied regardless of how long they may stay.

The new charges will also apply to reservations placed after 12:00 a.m. on 1 October 2019.
