NARITA INTERNATIONAL AIRPORT ADMINISTRATIVE REGULATIONS

(Provisional Translation)

[Objective]

Article 1

The purpose of these regulations is to set out provisions required to enhance the airport users' convenience by publicly disclosing the contents and extent of the Airport's services, in accordance with the provisions of the Airport Law (Law No. 80 of 20 April 1956) Article 12-1.

[Operating Hours]

Article 2

1. The operating hours of the Airport shall be for 24 hours per day. However, take-off and landing of aircraft shall, in principle, take place between 6:00am and 12:00am.

2. Approval of take-off and landing of aircraft between 11:00 pm and 12:00 am will, in principle, will be limited to aircraft using Runway A in accordance with the Narita International Airport Administrative Regulations (15 May 1978 Regulation No. 24) Article 26, Clause 1-1.

3. The operating hours of the essential facilities required for maintaining the basic and essential airport functions such as the passenger- and cargo- or freight-handling facilities, aircraft refuelling facilities as well as car parks will be determined separately and will be made public by the internet and other means.

Article 3

1. Runways (Length x width)

(1) Runway A: 4,000m x 60m (16R/34L)

(2) Runway B: 2,500m x 60m (16L/34R)

2. Single Isolated Wheel Load (SIWL)

(1) Runway A: 4 5t

(2) Runway B: 2 5t

3. Apron

171 berths

4. ILS Facilities

(1) Runway A: 2 sets available; Cat. III b (Approach on 16R); Cat. I (Approach on 34L)

(2) Runway B: 2 sets available; Cat. I

[Information on Services provided by the Airport]

Article 4

The following information will be made public by the internet and other means, in accordance with the detailed regulations set forth separately:

- (1) General Information and information on other facilities related to services provided by the Airport;
- (2) Designation, location, contact and other information related to the Airport operator ;
and
- (3) Any other information pertaining to services provided by the Airport.

[Provisions for Airport Users]

Article 5

Detailed provisions of the rules to be adhered to by all users of the Airport s services as well as the general public and other provisions required for installation, operation and management of the Airport are set out in the Narita International Airport Administrative Regulations (15 May 1978 Regulation No. 24).

Supplementary Provisions

These regulations have taken effect from 27 October 2019.
