

Revised Charges in Conjunction with Increase in Consumption Tax

Tokyo, 13 December 2013 : Narita International Airport Corporation (NAA) announces that, as a result of the consumption tax rate increase effective on 1 April 2014, the airport user fees and charges will be revised.

The consumption tax rate will be increased from 5% to 8%, and this change will be reflected on all fees and charges collected at Narita Airport. The fees and charges currently tax inclusive will be revised as follows:

1. Passenger Service Facility Charge (PSFC) and Passenger Security Service Charge (PSSC)

Effective Date: The new charges will apply to passengers using the airport on or after 1 April 2014, when their tickets are purchased on or after 1 February 2014. Current charges will apply to tickets purchased before this date.

* As before, PSFC and PSSC will be collected in conjunction with the airfare when passengers purchase their air tickets.
